INSTRUCTIONS CHANGE OF SIGNING OFFICERS FOR CORPORATE BRAND OWNER

This form must be completed by a Director of the corporate brand owner and submitted to Livestock Identification Services Ltd. (LIS) to remove signing officers and appoint replacement signing officers. LIS only accepts up to two signing officers for a corporate brand owner. If there is more than one signing officer, both signing officers must sign for the corporation on all brand transfers. All of the fields in the form must be filled in before the change will be accepted by LIS.

Brand owner	Enter the noted information for the corporate brand owner.
Brand Design	This is the characters used in the brand. The design must match what appears on the Brand Certificate and in the Brand Registry. The brand design must be provided.
Brand Location	This is the location of the brand as noted on the Brand Certificate and in the Brand Registry. The location must be provided.
Brand Type	Check whether this is a cattle or horse brand.
Effective Date	Enter the date the change is to be effective in the space provided
1. Signing Officer(s) being removed	Enter the full name and full address for the signing officer(s) being removed.
2. Signing Officer(s) being appointed	Enter the full name and full address for the replacement signing officer(s).
3. All Signing Officers after the change is made	Enter full name(s) and full address for each signing officer (maximum of two signing officers) that will be on record with LIS after this change is processed.
Signature, Date and Contact Information	Enter the name of the Director of the Corporate brand owner completing the form along with the Director's telephone number and e-mail address. The form must be signed and dated by the Director.
